

## **Terms and Conditions**

### **1. Scope of Application**

These Terms and Conditions apply to the following educational measures: Climate resilient homes and communities for Europe: working together for a just transition – Summer School for Early-Career Professionals, 04 July – 07 July 2023 (subsequently called “educational measure”) of EBZ Business School – University of Applied Sciences, Springorumallee 20, 44795 Bochum (subsequently also called “organizer” or “EBZ”).

### **2. Registration**

The registration for the educational measure is binding. The contract is concluded, when the organizer confirms the registration in written or electronic form (e-mail).

### **3. Admission requirements**

(1) Any interested person can participate in the educational measure of the organizer, who fulfills the admission requirements stated in the product description of the respective educational measure – under the provision that the maximum number of participants and the respective national contingent of participants has not been reached yet.

(2) The organizer decides whether the interested person fulfills the admission requirements. The organizer’s decision is final and not subject to legal appeal.

### **4. Implementation**

The organizer reserves the right to replace a speaker and/ or to relocate the event within the city of Bochum and to changes in the programme as the case may be, provided the aim of the educational measure is hereby not fundamentally changed.

### **5. Copyright**

The documents, software and other media for educational purposes delivered to the participant are protected by copyright. The reproduction, distribution or any otherwise use of delivered materials – also as excerpts – is only permitted after the expressive consent of the organizer in written form.

### **6. Cancellation**

The cancellation of registration is possible until 06 June 2023 at an extra charge of 75 EUR. It is to be sent in electronic form (e-mail) to [h.kubitza@ebz-bs.de](mailto:h.kubitza@ebz-bs.de). After 06 June 2023, the full participation fee has to be paid. Registered participants can transfer their participation rights to another eligible person according to the admission requirements. In that case, the organizer is to be informed in electronic form (e-mail) under [h.kubitza@ebz-bs.de](mailto:h.kubitza@ebz-bs.de).

### **7. Terms of Payment**

The participation fee is due in full upon receipt of the invoice. The payment is to be made in EUR to the bank account of the organizer specified in the invoice, quoting customer number and invoice number.

## **8. Cancellation of the event by the organizer**

The organizer reserves the right to cancel the educational measure due to a lack of participants or illness of teaching staff as well as other disruptions of business operations, for which the organizer cannot be held liable. In such a case, you will be informed as soon as possible. Participation fees that have already been paid, will be reimbursed in that case.

## **9. Place of fulfillment/ Place of jurisdiction**

Place of jurisdiction for all disputes that may arise from the contract is Bochum. German law applies.

## **10. Privacy Policy**

With regards to the legal provisions of the General Data Protection Regulation (GDPR), we would like to point out that your personal data given in the registration form will be stored and used to fulfill the contract. The fulfillment of the contract may include the sharing of personal data, if it is necessary for the implementation of the educational measure, e.g. with the head of the course and/ or other participants of the educational measure or the organization at the venue of the educational measure. In other respects, there is no sharing of your data with third parties, without your explicit consent.

## **11. Severability Clause**

Should any individual provision of these Terms and Conditions become ineffective, either in full or in part, this will not affect the effectiveness of the remaining provisions. The ineffective provision will be replaced by the legal regulation.
